5. State-BOD report

- a. Directors of Region 6 were not available to attend the last stated B.O.D meeting at the State level, the directors were made aware that a meeting was not held since a quorum was not present.
- b. Bruce contacted Mark Mitman about providing assistance to R6 when we host trainings, allowing R6 to continue to take online registrations and payment while operating under R6 preferred provider status, not under Pennbocs. Mark identified that it would not be an issue to continue, he will not be able to print certifications or use Pennboc's preferred provider number for our classes.



6. Old Business

a. Pittsburgh ICC Conference (2021)-

Jeff Frazier noted that a meeting was held on August 6th, the committee is still trying to break the event into segments and create groups for each portion. Jeff indicated that Jim Russell will be heading the Donation Committee.
