### WEDNESDAY, SEP. 21st

#### **MORNING SEMINARS:**

#### Historic Buildings & Codes 101: WYNTK for Working with Pennsylvania's Older and Historic Places

Ted Vedock, Hammel Associates Architects Shelby Splain, Megan McNish & Shawn Massey, PA SHPO

What makes a building historic, instead of just old? What should I know about rehabilitating a historic building and applying building codes? Where do I go if I have questions? Join staff from the Pennsylvania Historic Preservation Office and architect Ted Vedock from Hammel Associates Architects for an informative session that will give attendees the key information they need when it comes to historic buildings and codes. Topics include historic preservation players and programs, how to define "historic" when it comes to buildings and codes, and an in depth review of the Secretary of the Interior's Standards for Rehabilitation and the IEBC's Historic Building Code provisions illustrated with relevant case studies.

#### **Accessibility in Existing Structures**

Stephen Nowroski, City of Fastor Walter Schneider Witchib, CRCA

One of the great challenges in working with existing structures, is the implementation of the accessibility requirements of the International Building Code and International Existing Building Code. This session will investigate the challenges associated with the adaptation of existing buildings, and obtaining compliance with the accessibility provisions. The attendee is encouraged to bring their 2018 IBC, 2018 IEBC, and 2017 ICC A117.1 for reference.

#### 2018 ICC Permit Tech Institute (2 Days)

Tim Rvan, ICC Instructor

This two day ICC institute is designed to educate permit technicians with, skills and abilities necessary to perform their jobs more effectively. Topics covered include code administration, legal aspects,

code language, code enforcement, reading construction documents and the permitting and inspection process. Participants will become familiar with the International Building Code (IBC) and the International Residential Code® (IRC®) and sharpen their customer relations skills.

#### **Fire Protection in Historic Buildings**

Jesse Pfeifer, Adelphia Fire Protection The concern for public safely and the protection of property, within the context historic preservation, has led to challenges in the continuing use of historic properties. Older buildings, constructed before modern fire safety requirements were established, must be made safe for the public. This presentation will discuss the challenges of fire safety retrofitting in historic buildings.

#### **AFTERNOON SEMINARS:**

#### Masonry Related Changes from 2015 to 2018 IBC for Code Officials (Part 1: 2hrs) / Historic Masonry Repair & Restoration (Part 2: 1hr)

(Part 1 of Seminar) Brian E. Trimble, International Masonry Institute

Are you up to date with the masonry changes? This presentation covers relevant changes to masonry codes and standards applicable to the 2018 International Codes. There have been several major changes to the concrete masonry provisions, including requirements for concrete masonry unit geometry that provide more flexibility to designers. Some of the changes will make concrete masonry construction more cost-effective and efficient. These and other revisions to the IBC, IECC, and more will be covered so that you will be ready to enforce the updated provisions for masonry design and construction.

#### (Part 2 of Seminar) Casey A. Weisdock, International Masonry Institute

Get an overview of historic masonry wall assemblies and their evolution from mass, to transitional, to cladding systems. This session explores the differences between

these systems and how they function. Learn the rationale and methodology for condition assessment and gain insight into common types of deterioration and material characteristics. Understanding the material properties, the type of construction, and its vulnerabilities help in developing appropriate repair and restoration solutions. General appropriate masonry repair and replacement options are discussed for several types of masonry. Finally, see how craftworkers that are trained and educated in masonry restoration are assets to project teams and play a significant role in successful historic masonry projects. This is all tied into requirements found in the IEBC.

### **Courtroom Testimony & the Code Official**

Michelle Mayfield, Esc., MWM& P.C. This educational and informational presentation addresses legal elements associated with code enforcement and courtroom testimony. Attendees will learn and be encouraged to address daily complaints and enforcement actions as if those actions were heading to court. Emphasis will be placed on proper case preparation by the code official prior to and during complaint receipt or observation(s), the perseveration due process rights, and understanding court procedural rules regardless of the court proceeding level. Proper documentation, evidence collection and preservation, court preparation, and effective testimony will be covered throughout this informative session designed as a replicated court room set up within the classroom. Actual attorneys and a judge will facilitate the testimony portion. It is rare to find a practical testimony course designed for code officials particularly one overseen directly by officers of the court. A desire to learn and willingness to actively participate will best prepare the code official for any courtroom appearances.

#### Historic Sprinkler Systems in Existing **Structures**

Steven Schneider, Kistler O'Brien Fire Protection Session is intended to provide a basic understanding of the history and

evolution of fire sprinkler systems and the changes to the installation and maintenance requirements of these systems over the years. Beginning in the 1800's the progression of sprinkler systems will be presented and the changes to National Fire Protection Association standards based on experiences with these early systems. Requirements of the maintenance standard will be explained and why these requirements were deemed necessary.

### THURSDAY, SEP. 22nd

#### **MORNING SEMINARS:**

#### 2018 IEBC Essentials (Full Day)

Gil Rossmiller, ICC Instructor, Shams Coda Associates This full day Seminar will introduce critical concepts of the 2018 International Existing Building Code (IEBC). It will provide a basis for the correct use and application of the code. It will build an understanding of the intent of the code through detailing basic tables, categorizations and a case study. Following the training, attendees will be able to: recognize the limitations and extent of the codes related to existing buildings; recognize the classifications of work associated with existing buildings; identify fire protection systems that need to be upgraded; recognize vertical openings that need partial or complete enclosure; identify unsafe interior finishes that need to be replaced; determine adequate means of egress; identify needed accessibility improvements; identify improvements to structural systems; and, describe the compliance alternative tabular method of evaluating existing buildings.

#### **IPC and Existing Structures**

#### Jay Montgomery, City of Reading

The session will focus on the implementation of the plumbing code requirements on existing buildings. The attendee is encouraged to bring their copy of the 2018 IPC to session for reference.

#### **Current & Historic Fire Assemblies**

*Walter Schneider III, Ph.D., CRCA* Over the course of time, building construction has changed greatly. Similarly, the way the code looks at fire ratings has evolved as well. When dealing with historic structures it is important to understand how to properly calculate the fire resistance rating of existing construction assemblies. This program will focus on the evaluation of historic and modern fire assemblies and how to calculate the accepted fire resistance rating for use with the IBC, IEBC, and IFC.

#### **AFTERNOON SEMINARS:**

#### IMC & IECC and Existing Structures

*Walter Schneider III, Ph.D., Centre* Region Code Administration

The session will focus on the implementation of the mechanical and Energy code requirements on existing buildings. The attendee is encouraged to bring their copy of the 2018 IMC and IECC to session for reference.

#### **Fire Alarms & Historic Structures** *TBA*

In working with existing structures, it can be challenging to implement the fire detection and alarm requirements of the International Fire Code and NFPA 72. This session will look at the code requirements, and how to successfully incorporate these into existing and historic structures, to provide the minimum level of safety required.

### FRIDAY, SEP. 23rd

#### **MORNING SEMINARS:**

#### **Residential Energy in PA**

Brian Wolfgang, PHRC

One of the more challenging portions of the Uniform Construction Code (UCC) for residential builders is the ongoing evolution of energy code provisions. This session will provide an overview of the energy-related code provisions in the UCC with an emphasis on the recent changes associated with the 2018 ICC adoption. More specifically, this session will dive into some of the ongoing challenges faced by builders and contractors, including air sealing and blower door testing, energy code compliance paths, and the PA Alternative Residential Energy Provisions. This session will require some storytelling on the part of attendees – the speakers will want to know where the stress is the greatest in their markets as it relates to energy.

#### Adaptive Reuse of Existing & Historic Buildings Christine Usslemmeract, Inc.

This seminar will focus on using the International Existing Building Code with a focus on certified historic buildings and adaptive reuse. The complexities of interpretation and how the presenters worked with local code officials and historic review entities will be illustrated through two case studies, the adaptive reuse of a former silk mill complex and the renovation of an historic courthouse. The presentation will also explain how Federal historic tax credits and National Park Service requirements dovetail and increase the complexity of code compliance.

#### PA UCC Permit Process: Internal Best Practices for Your Jurisdiction

Walter Schneider III, Ph.D., CRCA

This program, will introduce the attendee to the requirements of the Pennsylvania UCC, the adoptive process, and the administrative provisions that need to be followed when administering the building codes in the Commonwealth of Pennsylvania. The attendee is encouraged to bring their copy of the PA UCC to the session for reference. #### **Fire Inspections on Existing Structures**

William Yeagley, Lower Allen Township James Lucas, Limerick Township

Annual inspections are completed to prevent catastrophic events that historically cause major damage and possibly take many innocent lives. This course is designed to assist the Fire Inspector in understanding what issues they may find daily.
